Hermann firmly believed that childhood experiences have a profound effect on the people we become. After losing his mother early in life, he

experienced firsthand the loneliness of a motherless childhood. Later, as a child welfare worker in the aftermath of World War II, he was deeply touched by the orphaned and abandoned children he worked with, and the hardships they endured.

Witnessing the deplorable conditions that plagued many traditional orphanages at the time, Hermann formed the strong conviction that children can only be helped if they have a home and a mother's love. He welcomed children to the first SOS Children's Village in 1949.

At SOS Children's Villages, we work to ensure that children grow up in a safe and caring family

Because of You, I Have Hope for the Future - Meet Akachi

That's how I felt when I first arrived at the SOS Village in Nairobi. My mama died when I was 4 and there was no one to take me in or care for me. I was an orphan. I found food however I could, but it was never enough. I begged from strangers. I stole from the market. I slept where I could. Mostly I went to sleep hungry, dreaming of food. I lived on the streets for two years.

One day I was hiding out after getting chased for stealing some cassava and I saw a man and a lady I'd never seen before. The lady had a big, friendly smile. The man wore a badge and carried a clipboard. When they found me, I thought I was in trouble. Instead, they told me they wanted to give me food, clean water, and a real bed to sleep in. I thought I must be dreaming.

But they were real. And the place they told me about was real. I got a new mama, clothes that didn't have holes, and I started going to school! I had to sit with the younger kids at first because I had never gone to school before, but I studied hard and now I sit with kids my age.

I'm so thankful that man and lady found me that day. Because of them, and because of you, I have hope for the future.

impressed me, is their long-term commitment. I'd become quite disenchanted with how many other development initiatives were so short-term. With SOS Children's Villages, its not a 1-2 year project. They start a village and make sure these kids get what they need. They 're actually accomplishing what they've set out to do."

Ama's Story

Arna lay on a stump near her aunt's house where she'd lived for the past two years. Tired, hungry, and in excruciating pain from a growing infection in her jaw, she had given up hope and was ready to die.

Ama's mother died during childbirth. When she was just four years old, her father was killed in an accident. Arna went to live with her two aunts and uncles, and 12 cousins.

In the crowded shack Arna was starved, abused, and neglected. She was forced to walk 10 km a day in the scorching Ghanaian sun gathering firewood and food to "earn her keep." If her aunt wasn't happy with what she found that day, she wouldn't be fed.

For two years, Arna endured a tortured life under her relatives' care. She had a roof over her head but certainly not a home.


One day, hungry and desperate for any type of nourishment, Arna tried to open a coconut - using her teeth! She heard a loud crack, followed by an intense pain in her jaw. Her face swelled up.

With no medical attention, her jaw only got worse. All she wanted was for her mother to come and take her. She had no hope and felt completely alone.

An SOS Children's Villages worker and a government official found Arna lying on the stump that day and offered her something she could have never imagined - a second chance at life.

Through SOS Children's Villages, Arna was given medical attention, a new home, brothers and sisters who understood what she'd been through, and most importantly, the unconditional love of an SOS mother.

Today, Arna is 11 years old and thriving. She wants to become a social worker, to help children like her escape abuse and neglect and have a chance at a real future. Arna is alive and well today because of you. Your compassion and generosity saved her life.
