Though living through the Second World War was not easy, Maria Virjee could always count on her mother's loving care. She knew that, sadly, many children had no one to rely on.

Maria was born in Vienna in 1936. Having grown up in Austria, where the first SOS Children's Village was created in 1949, she witnessed the importance of providing stable homes for children orphaned during the Second World War. After moving to Canada in the early 1960s, Maria continued to donate to SOS Austria. When SOS Children's Villages Canada launched in 1969, she became a volunteer. As the organization celebrates its 50th anniversary in Canada this year, Maria is still a proud volunteer, in addition to being a child sponsor.

A handful of years ago, Maria strengthened her commitment to SOS Children's Villages by leaving a gift in her will.

"It feels good to know that, after I'm gone, my bequest will be helping children throughout the world for generations to come," she says. "I share my story in the hope that it will inspire you to consider your own legacy, and a gift for future generations of children."

The men who kidnapped three-year-old Arif Haque planned to sell him as a jockey for camel races in India.

Arif eventually broke free from his kidnappers at an ai_{rp} ort. Though police rescued him, he spent the next eight years in Indian youth-detention centres.

SOS Children's Villages eventually intervened and brought Arifback to his native Bangladesh. The moment he arrived at a loving home in Dhaka is the moment everything changed.

"My first impression was that the SOS Children's Village was the safest place in the world," says Arif. "I could see my future. I felt I could do something with my life."

Thanks to the support and education you make possible, Arif is fulfilling his dream of becoming a doctor. He is grateful to donors like you who made his dream come true - and he is eager to pay your generosity forward.

"Once I was deprived, and I was helped. Now it is my responsibility to give back to society," he says.

Despite his busy schedule as a resident at Cairo University Hospital, Arif makes it a priority to care for those less fortunate. In 2017, he worked in the Rohingya refugee camps in Bangladesh, helping to provide health services to children and the elderly. He organizes free medical camps every six months for Bangladeshis living in rural parts of the country. After finishing his residency in 2020, Arifhopes to open an orthopaedic centre catering to the poor.

And I am grateful because you have equipped me with enough skills to face the world head on.


It is my prayer that you will continue to show love and kindness to those after me, that they will seize every opportunity that you make available to them and realize their dreams.

It's more than a village The SOS Social Circus program changes lives

Gabriela's tiny arms were covered in bruises when she came to live at SOS Children's Villages in Morelia, Mexico at just six monthsold. Despite her SOS mother's unwavering love, Gabriela's history of abuse led her to feel insecure and unlovable. As a young girl she threw tantrums, didn't obey and often rebelled.

Her SOS mother, Maria Luisa, says Gabriela's life changed when she joined SOS Social Circus, a unique program pioneered by Canada's own Cirque du Soleil. Its primary goal is not to learn circus arts, but to assist kids with their personal and social development.

"The culture of circus is all about humans who work together, supporting each other," says Emmanuel Bochud of Cirque du Soleil. "Offering an innovative way for kids and youth to express themselves, to explore, to learn and to take risks is essential."

Gabriela enjoyed her circus acrobatics classes, and loved learning how to walk in stilts with her instructor Alfonso. "I learned that if you work really hard at something, you can be good at it. One day, I want to become a teacher so I can help kids just like me," says Gabriela.

Gabriela's success story is one of many. Your support has helped SOS Social Circus transform the lives of more than 700 children since its launch in 2014.

"The SOS Social Circus program teaches you to value yourself as a person, to not be afraid. I feel supported. I'm part of a team now," says Gabriela.
