Why leave a gift to charity?

People from all walks of life choose to leave a gift to a cause they care about. Right now, more than 1.5 million Canadians have decided to include a gift to charity in their wills. Any gift, big or small, can truly make a difference. It also provides tax benefits that can relieve the burden of estate tax on your loved ones.

How does a gift in my will help children?

With your gifts, SOS Children's Villages helps children with the greatest need. From infancy to adulthood, we are there providing support in education, social services, food, shelter and family.

What about my loved ones?

It's important to care for those we love. Many people come to realize that they have enough in their estate to care for family members and also allocate a share to causes that are most important to them.

Do I need to change my entire will?

Even if you already have a will, you can include SOS Children's Villages using a special legal clause called a codicil. Or, simply add your gift next time you update your will.

Do I have to tell anyone about my decision?

Not at all. But if you wish to share this information with us, we'd welcome the opportunity to thank you personally.

Keeping Families Together

The Family Strengthening program helps widows start over

When Assanatou's* husband died, she didn't know what to do. "Coming back to square one after losing a husband, with no one to support you with the children is tough," she shares. But she didn't give up. "I had to be there for my children."

Assanatou moved her family – a teenage son and two nine-year-old twin daughters – to her brother's crumbling house on the outskirts of a large city. "When



I had a bit of money, I would prepare the meals and when I didn't, my brother's wife was there," says Assanatou. "When it came to food, we would first feed the children even if that meant that at times some adults would not eat. We worked things out with the little we had."

Assanatou's future began to brighten when she joined the SOS Children's Villages Family



Strengthening Program. She opened a small store selling household items, firewood, bread and coffee in the morning. Assanatou is now the president of a village loans and savings association and recently convinced three members to invest in a chicken farm.
