Finding her child powerless and in danger, Zala's mother brought her home after four months. But Zala was shamed for being divorced.

With extensive counselling and support from SOS Children's Villages Ethiopia, Zala gained the confidence to return to school.

Today, she is a community role model, raising awareness about the harmful effects of child marriage on girls' health and development.

Arsha's Journey: How you deliver hope and healing

A gift in your will can support the resilience and coping skills of children who have faced trauma.

When two-year-old Arsha* came to SOS Children's Villages in Bangladesh, she found refuge from the violence in her home. Arsha had witnessed the tragic murder of her mother.

Arsha seemed to have no memory of the horrific event. However, the world of childhood trauma is deeply complex. Buried memories of traumatic experiences can resurface years later.

At age seven, nightmares began interrupting Arsha's

sleep, leaving her exhausted and anxious. She couldn't focus on school or participate in family responsibilities. She even began picking fights with her siblings and schoolmates.

Thankfully, caregivers recognized her behavior as a symptom of a mental health crisis and turned to SOS programs funded in part through gifts made in donors' wills.

A psychologist guided Arsha through her healing, and helped her family understand

how they could support her. "My sister has become an inspiration on how to deal with mental health," says Arsha's SOS sibling Saba. "And she has taught me how to ask for help, too."

A gift in your will changes the course for children like Arsha. You deliver mental health support programs that create safe spaces, provide counselling and promote emotional well-being.

SOS Mothers: Love and Protection Above All

Nikuze Adrolata has lived her life with an unwavering commitment: protecting children who have lost parents.

After learning about a shortage of caregivers in Rwanda, Nikuze completed training to become an SOS mother. She joined SOS Children's Village Gikongoro in 1992.

Thanks to your ongoing support, SOS mothers like Nikuze throughout our villages live with children in family homes where they raise the children as their own, providing the love, comfort and security these children so desperately need.

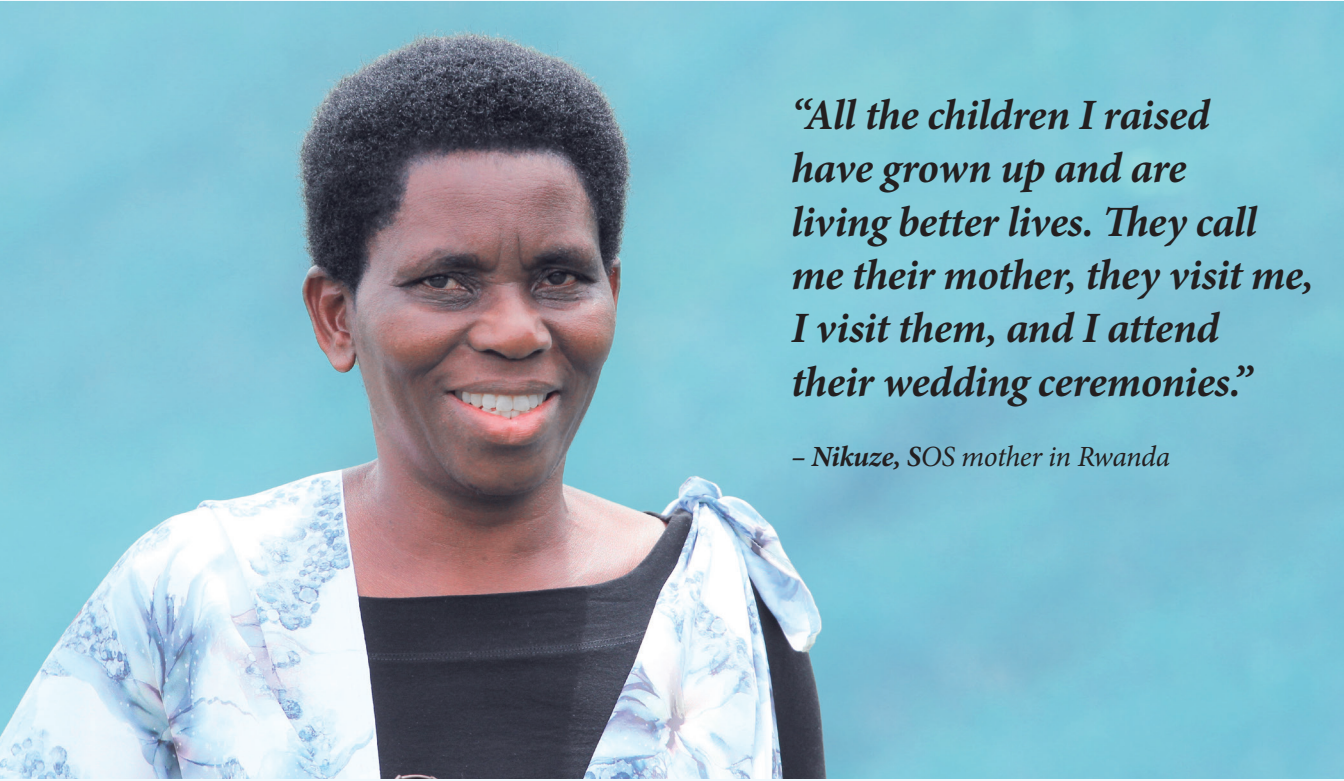
There's no force strong enough to deter Nikuze's fierce protective instincts when it

comes to her SOS children. During the 1994 Rwandan genocide, Nikuze fled with ten SOS children to a refugee camp. While there, she took in ten more abandoned children, returning home with all of them.

Nikuze has been recognized globally with the Helmut Kutin Award, given to extraordinary SOS Children's Villages workers who care for vulnerable children and lay the foundation for them to thrive into the future.

Nikuza credits the program that started it all, saying "I was lucky to join SOS Children's Villages and dedicate my life to child care."
